WORTH COUNTY ORDINANCE #2023-01

AN ORDINANCE READOPTING THE EXISTING COUNTY CODE AND ALL AMENDMENTS THERETO, WORTH COUNTY, IOWA

BE IT ENACTED by the Board of Supervisors of Worth County, Iowa:

Section 1. <u>Purpose</u>. Code of Iowa section 331.302(9) requires that once every five years a County shall compile its Code of Ordinances. This ordinance readopts ordinances already in effect, adopts ordinances that become effective after the last readopting and repeals any ordinance deemed no longer necessary to the operation of Worth County, Iowa or the health, safety, and welfare of its' citizens.

Section 2. <u>Readopting of Current Code.</u> The following ordinances have been previously adopted and enacted into law and were duly published as the law provides.
