## ORDINANCE AMENDING THE OFFICIAL WORTH COUNTY ZONING MAP – ZONING ORDINANCE #01/26/2009 as Amended by Ordinance 2022-05-16

## WORTH COUTY, IOWA ZONING ORDINANCE

(UNINCORPORATED AREAS OF BARTON, BRISTOL, BROOKFIELD, DANVILLE, DEER CREEK, GROVE, FERTILE, KENSETT, HARTLAND, LINCOLN, SILVER LAKE AND UNION TOWNSHIPS)

**LEGAL DESCRIPTION:** Parcel "E" located in part of the Southeast Quarter (SE ¼) of the Southeast Quarter (SE ¼) of section Nineteen (19), in Township One Hundred (100) North, of Range Twenty-one (21) West of the 5<sup>th</sup> P.M., Worth County, Iowa as described and depicted in a plat of survey filed May 26, 2022, in Document No. 20220582 as found in the office of the Worth County Recorder.

WHEREAS, Kristoffer and Addie Rugland have applied for re-zoning of the above referenced parcel in Section 19, Hartland Township from AG (Agricultural) to I-L (Light Industrial) in order to accommodate the building of a seed, fertilizer and chemical warehouse.

WHEREAS, at certain times it is necessary to amend the Worth County Official Zoning map and/or the text component which makes up the Worth County Zoning Ordinance.

WHEREAS, The Administrator of the Planning and Zoning Commission forwarded a recommendation for approval to the Planning and Zoning Commission, held a public hearing on August 29, 2023 in accordance with Iowa Code and has forwarded a letter of recommendation of approval to the Worth County Board of Supervisors for the rezoning of 11.88 gross acres noted herein above. The Planning and Zoning Commission, with a unanimous vote, recommends the approval of the petition by the Board of Supervisors with a recommendation of applicable DNR Permits.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF WORTH COUNTY, IOWA AS FOLLOWS:

**SECTION ONE:** That Worth County shall, and it does hereby, approve an amendment to the Worth County Zoning Ordinance that the property (see description above) be rezoned from AG (Agricultural) to I-L (Light Industrial).

**SECTION TWO:** Approval with the following conditions:

1. Recommendation of applicable DNR Permits.

**SECTION THREE:** That this amendment shall be in full force and effect from and after its passage and approval in the manner provided by law.
