Board of Trustees,

The approved construction of new district tiles starting this fall effectively will prevent the lands north of 450th Street from draining to the existing Drainage District No. 14 tiles south of 450th Street. The lands north of 450th Steet are included on the new assessment schedules filed with the reclassification report on May 28th, 2024. Therefore, we recommend the lands north of 450th Street be removed from the existing Drainage District No. 14 assessment schedule as the new tiles use a different outlet. We have included a list of the parcels to remove from the assessment schedule.

Upon review, we removed the SW SW of Section 34, parcel 0334300004, from the Upper Main Assessment schedule. This parcel appears to drain the other direction and does not benefit from the Upper Main. This lowers the total assessment for the Upper Main Assessment to \$124,975.05.
