 - b. I submitted a WCDA grant for a shelter supplies trailer this fall. Was not awarded. We can try again for the spring grant. Recommend putting it in the FY 2027 budget (\$10,000) and consider alternatives if we are not funded in the spring.
 - c. Exercises I have a Reunification and Recovery TTX planned with N-K Schools May 6th. I am looking at scheduling a Wide Area Search class for late March.
 - d. ESF 10 along with RSF Cultural and Natural Affairs will be reviewed in the spring.
 - e. EMPG 2025 grant update.
- 8. FY 2027 Budget Discussion
 - a. Salary increase % give direction as to what the commission would like to see. I have 2.5% on the sheet for an example.
 - b. Other areas of concern
 - i. Insurance what we had last year covered plenty, same amount again but budget for two years to get on the right cycle.
 - ii. Fuel prices are stable should be able to remain the same
 - iii. Office equipment I would like to revamp the office and standardize the cabinets with uniform cabinets and desk instead of a hodge podge of hand me downs and industrial racking. Add a small conference table and chairs. Estimating \$3,000 to do this.
