## Resolution 2025-47 Abolish the County Compensation Board

WHEREAS, the Iowa General Assembly has enacted legislation which allows county boards of supervisors to dissolve county compensation boards and assume the responsibility of setting salaries for elected county officials; and

WHEREAS, the Worth County Board of Supervisors recognizes the need to comply with this new legislation and streamline the process of determining compensation for elected officials;

NOW, THEREFORE, BE IT RESOLVED by the Worth County Board of Supervisors as follows:

Abolishment of the County Compensation Board: The Worth County Compensation Board is hereby dissolved effective immediately.

Assumption of Duties: The Worth County Board of Supervisors shall assume all duties previously assigned to the County Compensation Board, including the preparation and review of the compensation schedule for elected county officers.

Compensation Schedule: The Worth County Board of Supervisors shall prepare an annual compensation schedule for elected county officers in accordance with Iowa Code section 331.907.

Implementation: This resolution shall take effect immediately upon its adoption.
