Informed her that we have collaborated with Iowa Extension to do educational presentation for members of our community. Discussed with her the value of the outside grants as well as State Grants we can get to provide all the services that we feel members of our small county deserve to keep educated on healthy living, which encompasses physical, mental and spiritual health. Discussed the Opioid Settlement dollars, shared with Rep. Bloomingdale that our nurses are teaching in the classroom at NK CSD as well as educating the public on the dangers of opioid use. We also discussed how we have partnered with Prairie Ridge to do Narcan training in our communities and schools in the past and moving forward with the state's Narcan initiative we will provide the training and the distribution of Narcan with our own staff here at WCPH. Rep. Bloomingdale stated she would like to see students aged 9th-12th at all schools have the Narcan training as well. Shana stated she would be
